Barb Pochedly from the Portage County Outreach Department has been working on activity kits for senior citizens for use by activity directors in assisted living and nursing facilities. These kits contain books, movies, activities and other objects. They have completed kits on World War II, Collections, Kitchen Memories and Music and Movies of the 40's and 50's. These kits have been really well received and she is hoping that eventually they will be catalogued for patron use at the local libraries as well.

Pochedly is working on a School Days, Woodworking and Farm Day Kits. Any memorabilia for these themes; (e.g. old school books, pens and pencils, marbles with a case, a cowbell, old hats or clothing items, old small tools that aren't sharp (they have been looking for a small wooden plainer). Anything that spawns a memory and is small enough to fit into a 2-foot plastic tub is what they are looking for. The items below are from Scrapbooks # 64 (pages 19, 27, 32, 35) and # 132 (pages 19, 85, 108) located at the Portage County Historical Society. The newspaper clippings are most likely from the Ravenna Republican newspaper. Some of the clippings have no date but the information is valuable.

#### Beath of Mrs. Caroline M. Jennings.

"Life is a mystery as deep as ever death can be; Yet, Oh! how sweet it is to us, this life we live and see!"

Caroline M. Jennings, wife of S. F. Jennings and daughter of J. F. and Henrietta (Selby) Barker, was born in Ravenna, Ohio, October 10, 1837. Died March 4th, 1885, aged 47 years, 4 months and 24 days. December 25th, 1858, she married S. F. Jennings, by whom she was the mother of two children. The son, Harry B., now employed by a railroad company in Central America, was born May 16, 1863. An unnamed daughter died when but four days old. At the death of Mrs. Wm. B. Hopkins, her sister, Mrs. Jennings adopted her motherless little daughter Bertha J., born February 10th, 1875, but three days old at her mother's death. Mrs. Jennings leaves a devoted husband, an only son far away, the adopted daughter, a sister, Mrs. John Brigham, a brother, and an aged father to lament her death. death.

Mrs. Jennings was a long time an in-Mrs. Jennings was a long time to invalid, and at times a great sufferer, which she endured uncomplainingly. Having a firm belief in a higher and better life beyond the grave, she ever expressed a readiness and willingness to go hence when the summons should come.

Our sister was endowed by nature with more than an average of those graces. Without an enemy in the those graces. ## RAVENNA REPUBLICAN.

WEDNESDAY, SEPTEMBER 23, 1885.

-Saturday, John Black, of Monroeyille, Columbiana Ce., was taken in custody for trying to commit suicide by throwing himself before a passing train. He was locked up and in a short time was taken in a lit. He has been under the care of a physician since. Cause, too much whiskey.

-Last Friday while expressman Lewis and L. D. McGahan were removing seats from the rink, the herses suddenly started, throwing Lewis out and McGahan on the role between the horses. The horses ran, but were stopped by Adam Heisler and Mr. McGahan released from his uncomfortable position.

-John Breeze, the mail carrier, brought two young carrier pigeons to Rayenna from Palmyra. They were shut up on the way in paper bags, with holes cut to admit the air. They were let out at Ravenna twenty minutes apart. Both arrived home together in thirty minutes, a distance of fourteen miles.

-We are now possessed of a room suitable for large crowds and whose acoustic properties are of the best. We allude to the Rink. The seating capacity is 2,500 at least, and can be used for public ! gatherings. The Sherman meeting en Thursday last demonstrated its ability to accommodate a large crowd.

-Wednesday night four members of the Salvation Army were arrested for making a disturbance on the street by beating drums, singing, &c., and taken before the Mayor. The case was heard on Tuesday and the parties arrested held to bail to appear before the Grand Tury at the next term of Common Pleas.

Remarkable Case of Petrification.

Mr. John Hewitt, now nearly 78 years of age, who was the wagon-master of General Garfield's 42nd regiment paid us a call; one day last week. For a considerable part of the past year he has resided with his daugh. ter Mrs. L. L. Russell, in Ravenna township. In the course of his call upon us, Mr. Hewitt related a circumstance that is of public interest. For twenty five years Hiram Cadwell resided in Hiram township, and was a near neighbor of Mr. Hewitt. In the year 1870 Mr. Cadwell removed to Lansing, Mich., where he died almost 8 years ago, at an advanced age. A few days ago the remains of Mr. Cadwell were disinterred for the purpose of transferring them to another burlal place. When the grave was opened, to the surprise of those engaged in this work, the coffin was found to be so heavy that it could not be moved. Upon opening the coffin it was found that the body was completely petrifled, and the only possible way to get it out of the coffin was to pry it out with crowbars Eight men were required to lift and carry it The clothing upon the body was substantially intact. The features remained quite natural. and even a scar made by a razor cut while shaving the face, after death, was recognizable. The color of the face and body was of a brownish cast, instead of the pallor usually observable in death. Mr. Hewitt, between whom and the Cadwell family a relationship by marriage exists, had this narrative from a son of the late Hiram Cadwell. It is a remarkable instance of petrification.

#### Death of Hiram S. Beman.

Hiram S. Beman, an old resident of Ravenna, died at his residence a mile and a half north-west of Ravenna, Sept 80th, 1874, after a painful illness of two weeks, his medical attendant pronouncing his malady typho malarial fever with paralysis. During a large portion of his illness Mr. Beman was a great sufferer, and from the paralysis of his tongue was unable to swallow medicine or nourishment and to communicate but little. He received the most devoted attention from his family, relatives and neighbors, they thus exhibiting the tender interest they felt toward him. Mr. Beman was the son of Capt. Anson Beman, who died Sept. 29th, 1843, of typhoid fever with paralytic symptoms, at the age of 59 years. Capt. Beman was a pioneer settler of Ravenna, coming here quite young. Here he was married and here his seven children born, his deceased son Hiram being the second son and third child in againe of three sons and four daughters. The mother died March 22nd, 1832, and in eleven years was followed by the father, one daughter having died between the death of the parents, Mary Ann Beman, wife of Salmon A Taylor, who died at Monroe Falis, Oct.

Hiram S. Beafian was born on Beman Hill, Ravenus, Oct. 9th, 1816, and had nearly attained his 58th year at the time of his death. About twentytwo years since he married Sally King. No children were the product of this marriage, but by adoption two became inmates of this household.

Mr. Beman passed his days as a farmer. He was a quiet, unconspicuous, home loving man, but honorable, and upright, in his contact with men, a good and generous neighbor, an affectionate brother, and in every way a worthy citizen. In numerous traits he much resembled his father. It is a singular fact that both died of nearly the same malady and with only a day's difference, of the same month, the son having survived the father thirty-one years and one day. When Hiram was first taken ill he said: "When my father was taken sick and died he had his wheat-ground ready for sowing; mine is ready, as was his thirty-one years ago. I shall not get well. Others will sow and reap." His foreboding, or premonition, proved correct. He did not get well.

In addition to his wife and adopted children, he is survived by the following brothers and sisters Asahel C. Beman, residing at Bedford, Ohio; Truman M. Beman, residing at Hopkins, Allegan county, Michigan; Mrs. Emma Eliza Barber, at Chester, Ceauga county Ohio; Mrs. Harriet J., Mife of Wm. Carnahan, Esq. of Ravenna; Mrs. Rachel A. Wellman, of Dayton, Hennepin county, Minnesota. Mr. Beman was buried in the Ravenna Cemetery Oct. 2nd, 1874.

Sudden Death of S. J. Hopkins.

Samuel J. Hopkins, one of the best known citizens of Ravenna, died at his residence on Merid ian-st., at 5 minutes after nine o'clock, Tuesday evening, April 25, 1882, of total paralysts,

The attack was very sudden, and performed its office with rare swiftness. During the forencon Mr. Hopkins was engaged in his usual 'business affairs, and his cheeriness is now sadly remem bered by all who met him. About noon he complained of his head, and his physician was called It was thought congestion of the brain was emi nent. Shortly a condition of partial paralysis ensued, and at 3,45 became total, when he closed his eyes and opened them not again nor spoke. At five minutes after nine a second stroke visited

him and he immediately died. Mr. Hopkins was born Oct. 16, 1822, at Nelson, Portage Co., O., the son of Rossiter and Maria Sherwood Hopkins. When he was seven years of age his parents both died, and he went to live with his uncle, Samuel Hopkins, at Cornwall, Conn. His uncle died when the nephew was sixteen years of age, and he went to Terryville, Conn., where he acquired the trade of a lockmaker. In the year 1843, when he attained his 21st year, he paid a visit to Ravenna and Nelson, and after remaining here a few months, in company with his brother Duane, he purchased a horse and buggy, and the two journeyed back to Connecticut. In 1847 he returned to Ravenna and has since resided here. For about six months he was employed by R. A. Gillette as a clork in his store, and then entered the employ of H. Y. Beebe, Esq., as deputy-clerk of the Court. This engagement terminated in February 1851, with Mr. Beebe's retirement from the position as clerk of Courts. Mr. Hopkins then entered the employ of the late Cyrus Prentiss, as his book-keeper and confidential clerk. Shortly after Mr. Prentiss admitted him to partnership, and the firm of Prentiss, Hopkins & Co. continued business until the death of Mr. Prenties, July 31, 1853. The firm was then Carrie Richardson Griffin, Messrs, J. H. Oakley changed to Prenties & Hopkins, J. C. Prenties G. P. Reed. The pall bearers were D. M. Clewell taking the place of his uncle as the head of the house. January, 6, 1860, the store they occupied. upon the site of the present Etna Block, was receiving vault at Maple Grove Cemetery. burned, and in a short time the business of the firm was wound up. In the year 1861 Mr. Hop-

kins joined his brother Bradford S. Hopkins and formed the firm of B. S. Hopkins & Bro., cheese merchants. This partnership was closed by the death of B. S. Hopkins, Dec. 28, 1875, since which time Mr. Hopkins bas continued the business, for the last few years associating with himself his son, C. P. Hopkins.

Hopkins, Clara S., and Arthur P., survive him; Of Mr. Hopkins' eight brothers and sisters, three now survive, Titus B. Hopkins, Mrs. Lucinda Tilden, wife of H. C. Tilden, Esq., of Nelson, Wm. H. Hopkins, residing at Somerville, a suburb of Boston, Mass.

In the fall of 1881, accompanied by his daughter Clara, Mr. Hopkins made a trip to New England visiting for the last time the familiar scenes of his howhood and youth. He returned home October

21st and about a week afterward he had a dizzj sensation in the head. Since then, such periodi have been more or less frequent, and his family had entertained some fears that sooner or later this visitation might eventuate in paralysis.fears which were, it seems, well founded.

Mr, Hopkins lived a blameless life, and when not employed about his business, passed his hours of leisure in domestic re-tirement, finding in his home all the companion ship and social delight he craved. His busines affairs were always in a compact shape, and his conservative methods secured the continued pros perity of his enterprises. He enjoyed the univer sal respect of his fellow-citizens, and in the ex tensive circle of his business relations univers a regret is felt at his death .

The funeral of Mr. Hopkins took place Thursday afternoon at 1 o'clock, from his late residence, and the sympathy felt for his family was attested by the attendance upon the last tribute of earth Rev.
